



ALL TRAVELERS must include the following documents in your package to G3:

- Your original valid signed passport. It must have at least two blank pages marked "Visas" side by side and more than six months before expiry.
- One visa application form (attached), completed and signed with a pen-to-paper signature in blue or black ink; make sure the signature matches the signature in the passport. Ensure that the entry and exit dates listed on the application are correct and match the dates on the flight itinerary and letter to the Embassy, as the visa will be issued for these precise dates.
- One passport-style (2"x2") photograph taken within the last 6 months (must be on photo paper and have a plain white background).
- Copy of confirmed flight itinerary showing applicant's name.
- An official business or tourist invitation from the host in Kazakhstan. Invitations are not required for US, Canadian or EU citizens who request tourist visas or single entry business visas. US citizens may also request a multiple entry business visa valid for 5 years without an official invitation. If you require an official invitation, G3 can assist in acquiring the official invitation; see details on page three. Contact G3 for additional invitation options. Please note that invitation fees and processing times are in addition to visa processing fees and times.

BUSINESS and FLIGHT CREW TRAVELERS must also include:

- A letter from their U.S. company explaining the purpose of their trip and providing a financial guarantee. The letter must bear the original pen-to-paper signature of a company representative other than the applicant. For 5 year multiple entry requests, the letter must specifically request the 5 year visa duration. A sample letter is attached.

TOURIST TRAVELERS must also include:

- A letter addressed to "Embassy of Kazakhstan" describing the trip, signed by the applicant with a pen-to-paper signature in blue or black ink. A sample letter is attached.

WORK PERMIT APPLICANTS must also include:

- The official work permit invitation issued by regional authorities in Kazakhstan. Faxed or scanned copies are accepted.
- A copy of the permission for foreign labor recruitment, if the employment is not regulated by an international treaty or Republic of Kazakhstan agreement.

NON-US CITIZENS must also include:

- A copy of their Permanent Resident Card or U.S. Visa and I-94. Travelers who entered the US after April 26, 2013 should print the electronic I-94 form from <https://i94.cbp.dhs.gov/>.

MINORS UNDER AGE 18 must also include:

- A letter from the applicant's parents addressed to "Embassy of Kazakhstan" describing the trip and requesting that a visa be issued. The letter must be signed by both parents with pen-to-paper signatures in blue or black ink.
- Photocopies of the information/photo page of both parents' passports.
- Copy of the applicant's birth certificate showing both parents' names.

VISA NOTES

- These instructions are applicable for residents of Alabama, Arizona, Arkansas, California, Colorado, Delaware, District of Columbia, Florida, Georgia, Hawaii, Illinois, Indiana, Kansas, Kentucky, Louisiana, Maryland, Mississippi, Missouri, Nebraska, Nevada, New Mexico, North Carolina, Ohio, Oklahoma, Puerto Rico, South Carolina, Tennessee, Texas, Utah, Virginia, and West Virginia.
- From July 15, 2014 to December 31, 2017, citizens of USA, United Kingdom, France, Germany, Italy, Japan, Malaysia, South Korea and the United Arab Emirates will not require visas for stays of up to 15 days.
- Multiple entry tourist, business, and flight crew visas valid for 5 years are available to US citizens only. Applicants requesting 5 year validity must have at least 5 1/2 years validity remaining on their passports.
- The Embassy of Kazakhstan is closed every Wednesday. Wednesdays are not counted as a processing day.

PROCESSING NOTES

- Send all required documents and the completed Visa Order Form to G3 using a service with tracking such as FedEx or UPS.
- Due to submissions deadlines set by consulates and agencies, documents received by G3 after 8:30 am are hand-carried to the appropriate processing facility the next business day. 8:30 am delivery via FedEx or UPS with no signature required is recommended for requests requiring Mission Critical service. Mission Critical processing may not be available to travelers of some nationalities.
- Requests to expedite visa processing after the application has been submitted to the consulate will result in significant additional charges.
- Consular Fees include a \$5 Money Order fee.
- Credit card payments are subject to a 5% credit card convenience fee unless the physical card is presented in person.
