



ALL TRAVELERS must include the following documents in your package to G3:

- Your original valid signed passport, plus one photocopy of the information/photo page. It must have at least two blank pages marked "Visas" side by side and more than six months before expiry. (For 5 year visas, submit a photocopy of the passport; you will send in your original passport when visa approval has been granted. See the following page for more information.)
- One visa application form, completed online at www.kenyaembassy.com/dcservices/appforvisaonline.aspx, printed and signed with a pen-to-paper signature in blue or black ink; make sure the signature matches the signature in the passport. If you would prefer to have a G3 associate complete your online application for you, please contact ConciergeDesk@g3visas.com. (Submit two signed copies of the application for 5 year visa requests.)
- Two identical passport-style (2"x2") photographs taken within the last 6 months (must be on photo paper and have a plain white background).
- Copy of flight itinerary showing applicant's name.

BUSINESS and FLIGHT CREW TRAVELERS must also include:

- A letter from their U.S. company explaining the purpose of their trip and providing a financial guarantee. The letter must bear the original pen-to-paper signature of a senior manager other than the applicant. Please see the attached sample letter.

NON-US CITIZENS must also include:

- A copy of their Permanent Resident Card or U.S. Visa and I-94. Travelers who entered the US after April 26, 2013 should print the electronic I-94 form from <https://i94.cbp.dhs.gov/>.

MINORS UNDER AGE 18 must also include:

- Photocopy of the applicant's birth certificate showing both parents' names.
- Photocopies of both parents' driver's licenses or passports.
- If the applicant will be accompanied by someone other than their parents, submit a letter of consent signed by both parents. This letter must be original (no faxes, scans, or copies) and must include the applicant's name, the name of the escort, and explain the purpose of the journey and the relationship of the escort to the applicant.

VISA NOTES

- Multiple entry visas are available for US citizens only. Non-US citizens will be issued single entry visas and are subject to different consular fees than US citizens.
- Multiple entry visas valid for 5 years are available for US citizens only, for business or tourist purposes. 5 year visas require the approval of immigration authorities in Nairobi; approval times vary and may be several weeks or more. Applicants may submit all required documents along with a photocopy of their passport, and send in the original passport for visa processing after visa approval has been granted.
- The East Africa Tourist Visa allows leisure travel between Kenya, Rwanda, and Uganda with the same multiple entry visa.
- For visa requests requiring Mission Critical processing, travelers must send a copy of their passport and visa application to G3 by email (WashingtonDC@g3visas.com) or fax (703.524.3374) in advance of sending in the original documents. G3 must receive all original documents no later than 8:30 AM. Please send paperwork via FedEx or UPS with no signature required.

PROCESSING NOTES

- Send all required documents and the completed Visa Order Form to G3 using a service with tracking such as FedEx or UPS.
- Due to submissions deadlines set by consulates and agencies, documents received by G3 after 8:30 am are hand-carried to the appropriate processing facility the next business day. 8:30 am delivery via FedEx or UPS with no signature required is recommended for requests requiring Mission Critical service. Mission Critical processing may not be available to travelers of some nationalities.
- Requests to expedite visa processing after the application has been submitted to the consulate will result in significant additional charges.
- Consular Fees include a \$5 Money Order fee.
- Credit card payments are subject to a 5% credit card convenience fee unless the physical card is presented in person.
- The issuance of visas, including visa duration and number of entries, is at the discretion of the Consulate. G3 acts on the behalf of the client, and takes no responsibility for the services rendered by Travel Agents, Government Agencies, Consulates or Embassies in connection with issuance of visas and passports.
