



ALL TRAVELERS must include the following documents in your package to G3:

- Your original valid signed passport, plus one photocopy of the information/photo page. It must have at least two blank pages marked "Visas" side by side and more than six months before expiry.
- One visa application form (attached), completed and signed with a pen-to-paper signature in blue or black ink; make sure the signature matches the signature in the passport.
- One passport-style (2"x2") photograph taken within the last 6 months (must be on photo paper and have a plain white background). Attach the photo with glue or a paper clip; do not staple to the application.
- Copy of flight itinerary showing applicant's name.

BUSINESS and FLIGHT CREW TRAVELERS must also include:

- A letter from their U.S. company explaining the purpose of their trip and providing a financial guarantee. The letter must bear the original pen-to-paper signature of a senior manager other than the applicant. Please see the attached sample letter.
- A letter of invitation from the organization to be visited, certified by the State Foreign Citizens Registration Service of Turkmenistan.

TOURIST TRAVELERS must also include:

- An official letter of invitation from a Turkmenistan tourist agency, or a letter of invitation from a private host certified by the State Foreign Citizens Registration Service of Turkmenistan.

NON-US CITIZENS must also include:

- A copy of their Permanent Resident Card or U.S. Visa and I-94. Travelers who entered the US after April 26, 2013 should print the electronic I-94 form from <https://i94.cbp.dhs.gov/>.

- The certification of business and tourist invitations by the State Foreign Citizens Registration Service of Turkmenistan is valid for only three months; the visa application and invitation must be submitted to the Embassy within that three months.
- Invitations typically take 15 business days to be certified by the State Foreign Citizens Registration Service of Turkmenistan.
- Travelers who will spend more than three business days in Turkmenistan must register with the State Migration Service (SMS). SMS offices are located in Ashgabat, Dashoguz, Mary, Turkmenabat, and Turkmenbashi.

**PROCESSING NOTES**

- Send all required documents and the completed Visa Order Form to G3 using a service with tracking such as FedEx or UPS.
- Due to submissions deadlines set by consulates and agencies, documents received by G3 after 8:30 am are hand-carried to the appropriate processing facility the next business day. 8:30 am delivery via FedEx or UPS with no signature required is recommended for requests requiring Mission Critical service. Mission Critical processing may not be available to travelers of some nationalities.
- Requests to expedite visa processing after the application has been submitted to the consulate will result in significant additional charges.
- Consular Fees include a \$5 Money Order fee.
- Credit card payments are subject to a 5% credit card convenience fee unless the physical card is presented in person.
- The issuance of visas, including visa duration and number of entries, is at the discretion of the Consulate.
