

IMPORTANT VISA INFORMATION

Dear Traveler,

As you prepare for your upcoming experience with Discover Corps, we would like to inform you that a tourist visa is required for your visit to India. This visa must be obtained in advance of your departure from the United States.

As the Indian online application is difficult to navigate, we have enclosed a customized visa questionnaire and an instruction sheet from G3 Global Services.

To apply through G3, please complete the included questionnaire, scan and e-mail it to <u>DiscoverCorps@g3visas.com</u>. A G3 associate will then complete the online application for you and will email (or mail) back your completed e-Tourist visa. **Please note there are additional requirements for travelers under age 18.**

We recommend that you apply for your visa 6-8 weeks prior to your US departure. Please use an email address that you check regularly, as your completed eVisa will be returned via email.

Please ensure that your passport has at least two sets of blank pages marked "Visas" and will be valid for at least six months following your tour. G3 Global Services can assist with new passports and passport renewals, if necessary.

- Completed Indian Visa Questionnaire (one per guest)
- A color scan of the information/photo page of your original valid signed passport. It must have at least two blank pages marked "Visas" and more than six months before expiry.
- A digital image of a passport-style photograph taken within the last 6 months (JPG format preferred). The photo must be in color, taken against a plain white background. Do not wear glasses in the photograph.
- This cover sheet with all fields completed. Only one cover sheet is required per family.

Notes: Your India visa must be obtained before travel; please apply for your visas 60-75 days ahead of departure.
