- Completed Pakistan Visa Questionnaire (one per guest)
- A color scan of the information/photo page of your original valid signed passport. It must have at least two blank pages marked "Visas" side by side and more than six months before expiry.
- A copy of confirmed hotel reservations for the full duration of your trip, OR a letter of invitation from a Pakistan tour operator specifying all details of your trip. The names of all applicants must be listed.
- A digital image of a passport-style photograph taken within the last 6 months (JPG format preferred). Do not wear glasses in the photograph.
- This cover sheet with all fields completed. Only one cover sheet is required per family.

Your Pakistan eVisa will be sent to you via email. Allow 8-10 business days for your visa to be completed and emailed to you. Please apply for your visa 60-75 days ahead of departure
