Australia

As you prepare for you program, please be aware that US citizens are required to obtain an electronic visa known as an ETA prior to departure for Australia. You will not be able to board your flight to Australia without this electronic visa.

Instructions for US Citizens

To acquire an ETA please visit the Australia Immigration website at https://www.eta.immi.gov.au/ETA/etas.jsp and follow the instructions provided. This is a fairly straightforward process that should not take long to complete. If you have any questions please feel free to reach out to your personal travel advisor.

When to Apply

We recommend you apply for your ETA about one month prior to your departure for Australia. Your ETA will be valid for a twelve-month period.

Important Notes

- You must have your passport, email address and a credit card to complete the online application.
- You should apply for a tourist ETA for your Rustic Pathways program. Do not apply for a business, short-term work or other kind of visa or ETA for your program.
- There is a \$20 fee for the ETA that can be paid by credit card online.
- You must have at least one blank visa page in your passport when traveling to Australia.
- We recommend your passport has at least 6 months validity after your departure from Australia.

Rustic Pathways has partnered with the visa processing service G3 Global Services to make the process as simple as possible. G3 Global Services is a third party visa processing company and use of their services requires fees paid directly to G3.

G3 Global Services can assist with the following:

- For US Citizens and residents, G3 can assist with visa applications as well as passport renewals for a fee paid directly to G3.
- For non-US citizens and residents, G3 can provide information on visa requirements for each country free of charge.
