


Photo and Special Requirements CHINA

PHOTO REQUIREMENTS

The photo you submit for your China visa must meet all of these requirements:

- Your photo must have a plain white background and be on photo paper.
- Your head must measure between 11/8" to 11/4" from the top of your head to the bottom of your chin. The width of your face should measure between 5/8" to 7/8".
- You must have a neutral expression, looking straight forward at the camera. Do not smile in the photo.
- Do not wear glasses, hats, headbands, jewelry, or white clothing that would blend in with the background.
- Your hair must not cover your eyes, eyebrows, or ears.
- Attach your photo to the application with a paper clip. Do not staple, tape, or glue the photo.



Digital Photo Service is available to make sure your photo meets consulate requirements. Simply email G3 a digital photo of yourself against a blank white background, and we will format it and print it for you.

SPECIAL JURISDICTIONAL REQUIREMENTS

Residents of some states are subject to special requirements.

Residents of Alabama, Arkansas, Georgia, Florida, Louisiana, Mississippi, Puerto Rico, Oklahoma, Texas, and the US Virgin Islands:

• If you are employed or enrolled in higher education, you must complete and sign a supplemental form; contact G3 to request this form. (Not required for homemakers, children of high school age or younger, retired or unemployed people.)

Residents of Alaska, Northern California (zip codes starting with 94 or 95), District of Columbia, Delaware, Idaho, Kentucky, Maryland, Montana, Nebraska, Nevada, North Carolina, North Dakota, Oregon, South Carolina, South Dakota, Tennessee, Utah, Virginia, Washington, West Virginia and Wyoming:

- If your passport was issued less than two years ago, you must also submit your previous passport book.
- If you are not able to submit a previous passport book -- either because you have never been issued a passport before, or because your previous passport book was lost or stolen -- you must explain this in section 3.7 of the visa application.

Residents of Arizona, Southern California, Hawaii, New Mexico, and US Pacific islands:

- Travelers from these states require a slightly different visa application form; contact G3 to obtain this form.
- Non-US citizens must submit a signed, notarized letter confirming their residential address in the US.
- Travelers who have previously held a different nationality or who were born in a country other than their country of citizenship must submit a signed, notarized letter confirming their current nationality, previous nationality, and whether they currently hold more than one citizenship.
- Dual citizens, including US citizens who also hold the citizenship of another nation, are required to submit their applications in person at the consulate and have their fingerprints taken.

Residents of Colorado, Illinois, Indiana, Iowa, Kansas, Michigan, Minnesota, Missouri, and Wisconsin:

- If your passport will expire in less than one year, you will be issued a visa valid for no longer than six months.
- Applicants whose passport will expire in less than one year must submit a signed form letter stating that they understand that they will be issued a shorter duration visa, rather than a 10 year multiple entry visa. Please contact G3 to request this form letter.
