

2019 Visa Information China

As you prepare for your program, please be aware that a tourist visa for your visit to China must be obtained in advance of your departure. Below is important information to help you get you started with the application process.

In order for us to prepare the required documentation for your visa application and bookings in China, **Rustic Pathways must have your complete passport information at least 95 days prior to your departure.** If you have not already submitted this information to Rustic Pathways please do so as soon as possible via your personal travel advisor. You will not be able to apply for your visa if you have not submitted this information.

Instructions for US Citizens

US Citizens are required to obtain a tourist visa prior to departure for China. We strongly encourage you to utilize a visa processing service to assist with the visa application due to the complexity of the process. Rustic Pathways has partnered with the visa processing service G3 Global Services to make the process as simple as possible. G3 Global Services is a third party visa processing company and use of their services requires fees paid directly to G3.

To have G3 assist with your application process, please follow the application instructions below and complete the attached forms. If you have any questions or problems as you move through this process, please reach out to G3 directly at 888-883-8472 or RusticPathways@g3visas.com. G3 has staff dedicated to supporting Rustic Pathways students ready to assist you.

Should you choose to apply for your visa directly through an embassy or different visa processing service, please contact your Rustic Pathways personal travel advisor for any additional information needed to complete the application form. The application forms below are valid for use with G3 Global Services only.

Important Notes

- **We recommend that you apply for your visa 6-12 weeks before departure.** The Chinese consulates will not accept visa applications more than 12 weeks before departure.
- **Please ensure that your passport has at least two sets of blank pages marked "Visas" and will be valid for at least six months following your tour.** G3 can assist with passport renewals if you choose. Please note that it is no longer possible to add additional pages to US passports.
- We highly recommend you use a trackable delivery service such as FedEx or USPS Express Mail when sending your passport to G3 or other visa services or consulates. Please be sure to use a service that enables you to track your package and provides a delivery confirmation.
- For students under 18, parents must need to sign and notarize **two (2) copies of the Consent to Travel Statement.** One copy should be submitted to G3 and one should be taken with you to China. The consulate needs a copy and you need a copy when traveling.
- Please make sure to sign all forms where needed. If under 18, please make sure that both parents and students sign the application form where indicated.



Instructions for Citizens of Countries Other than the United States

The requirements for visa applications vary by nationality. To begin your visa process, we encourage you to reach out to G3 Global Services, a US-based visa processing service with whom Rustic Pathways has partnered, to obtain guidance on the steps you will need to take.

G3 is able to process visas for non-US citizens who reside in the US and will provide guidance for travelers who reside outside the United States. G3 will refer non-US residents to the appropriate embassy, consulate or resource as needed free of charge.

Each Traveler Must Send the Following Documents to G3:

- Your original valid signed passport. It must have at least two blank pages marked "Visas" side by side and more than six months before expiry. G3 can assist with expedited passport renewals and additional passport pages.
- One visa application, completed and signed in blue or black ink. The application must be typed or completed on the attached fillable PDF and printed; handwritten applications are not accepted.
- One passport style photo, on photo paper with a plain white background, attached with a paper clip. (See next page.)
- A copy of your driver's license or a utility bill in your name showing your street address.
- This completed Visa Order Form; only one Visa Order Form is required per family.
- Minor visa applicants under age 18 must submit the following additional items:
 - Photocopy of your birth certificate showing both parents' names.
 - Photocopy of both parents' passports (photo/signature page) and driver's licenses.
 - Notarized Consent to Travel form (attached) signed by both parents.
 - Part 4 of the application must be signed by both parents and the student; part 5 must be signed by a parent.
- Please see the following page for supplemental requirements based on your state of residence.

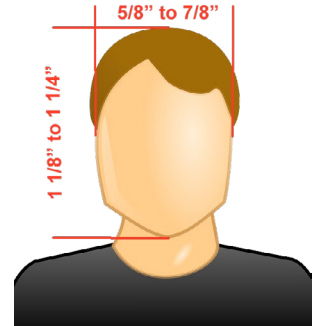

PHOTO REQUIREMENTS

The photo you submit for your China visa must meet all of these requirements:

- Your photo must have a plain white background and be on photo paper.
- Your head must measure between 1¹/₈" to 1¹/₄" from the top of your head to the bottom of your chin. The width of your face should measure between 5⁵/₈" to 7⁷/₈".
- You must have a neutral expression, looking straight forward at the camera. Do not smile.
- Do not wear glasses, hats, headbands, jewelry, or white clothing that would blend in with the background.
- Your hair must not cover your eyes, eyebrows, or ears.
- Attach your photo to the application with a paper clip. Do not staple, tape, or glue the photo.

SPECIAL JURISDICTIONAL REQUIREMENTS

Residents of some states are subject to special requirements.

Residents of Alabama, Arkansas, Georgia, Florida, Louisiana, Mississippi, Puerto Rico, Oklahoma, Texas, and the US Virgin Islands:

- If you are employed or enrolled in higher education, you must complete and sign a supplemental form; contact G3 to request this form. (Not required for homemakers, children of high school age or younger, retired or unemployed people.)
- Rush processing is not available to residents of these states.

Residents of Alaska, Northern California (zip codes starting with 94 or 95), District of Columbia, Delaware, Idaho, Kentucky, Maryland, Montana, Nebraska, Nevada, North Carolina, North Dakota, Oregon, South Carolina, South Dakota, Tennessee, Utah, Virginia, Washington, West Virginia and Wyoming:

- If your passport was issued less than two years ago, you must also submit your previous passport book.
- If you are not able to submit a previous passport book -- either because you have never been issued a passport before, or because your previous passport book was lost or stolen -- you must explain this in section 3.7 of the visa application.
- Rush processing is not available to residents of these states.

Residents of Arizona, Southern California, Hawaii, New Mexico, and US Pacific islands:

- **Travelers from these states require a slightly different visa application form; contact G3 to obtain this form.**
- Non-US citizens must submit a signed, notarized letter confirming their residential address in the US.
- Travelers who have previously held a different nationality or who were born in a country other than their country of citizenship must submit a signed, notarized letter confirming their current nationality, previous nationality, and whether they currently hold more than one citizenship.
- Dual citizens, including US citizens who also hold the citizenship of another nation, are required to submit their applications in person at the consulate and have their fingerprints taken.

Residents of Colorado, Illinois, Indiana, Iowa, Kansas, Michigan, Minnesota, Missouri, and Wisconsin:

- If your passport will expire in less than one year, you will be issued a visa valid for no longer than six months. You must submit a signed form letter stating that you understand that you will be issued a shorter duration visa, rather than a 10 year multiple entry visa. Contact G3 to request this form letter.
