2019 Visa Information Irawaddy Village Service

All students are required to obtain a tourist visa for Myanmar prior to departure for your program. Below is basic information to help you get you started with the application process.

Myanmar E-Visa

Tourist Visas for Myanmar can be obtained online by completing the online application process. Here are the instructions:

- 1. A current passport style photograph must be uploaded and submitted with Myanmar E-Visa application. The photo should be have a white background and you should be sitting straight and looking directly at the camera. You can find an example on the e-visa website.
- 2. You will need a MasterCard, Visa or American Express card for payment of Myanmar E-visa fee (\$50USD).
- 3. Please ensure your 'pop up blocker' is turned off when going through this e-visa process. You will need a pop up window to provide next step information.
- 4. Visit the Government of Myanmar website at <u>http://evisa.moip.gov.mm/NewApplication.aspx</u> to complete the application.

When to Apply

We recommend you apply for your visa **4-6 weeks prior to departure.** The E-Visa approval letter must be used to enter Myanmar within 90 days of issue. It takes about 5-10 days to process the visa.

Once you have completed the electronic application you will receive an email acknowledgement. Please be sure to print your reference number upon confirmation of payment (MasterCard, Visa, American Express are accepted). Within 3-10 business days, you should receive a Visa Approval Letter containing a barcode. If you do not receive the Approval Letter, keep checking the status of your application on the Myanmar immigration website using your application number and passport number (<u>http://evisa.moip.gov.mm/statusenquiry.aspx</u>).

You are required to bring this Visa Approval Confirmation Letter with you to Myanmar as Ministry of Immigration and Population requires you to produce it for verification when you arrive in Myanmar.

Important Notes and Details for All Applicants

- Your passport must be valid for six months from the date of departure from your home country.
- Your passport must be signed
- We strongly recommend you have at least <u>EIGHT</u> blank pages available including four blank pages marked "VISAS" side-by-side..

Students Under 18 Years of Age

- For students under 18, we strongly recommend you bring the following with you on your program:
 - o A copy of your birth certificate
 - o A copy of your parents' passports or driver's license
 - The signed and notarized Consent to Travel Statement that can be found at http://rusticpathways.com/forms/downloads/.
